- ☐ Do you understand how an Options contract gains or loses value with changes in price, depending on whether it's a Put or a Call, and whether the price is rising or falling?
- ☐ Do you understand how an Options contract gains or loses value with changes in time, depending on whether you have sold or bought the Option to open?
- ☐ Do you understand how an Options contract gains or loses value with changes in Implied Volatility, depending on whether you have sold or bought the Option to open?
- ☐ Do you understand how to "sell to open" as well as "buy to open?"
- ☐ Have you built your Business Plan?
- ☐ Have you created a Trading Plan?
- ☐ What trading system are you using? Have you defined it in your Trading Plan?
- ☐ What risk are you taking on each trade? What are your stops?
- ☐ What broker are you planning to investigate and use?
- ☐ Have you figured out how to be your own performance coach?

You might not have all of those items in place yet, and perhaps you've only been able to check off a few boxes. That's OK, everyone has to start somewhere. Just don't put any LIVE capital at risk while you learn! There's no point in funding someone else's account until you're ready and have an edge.
